

2/ Let's walk through some examples of the most egregious skills for scams done by Soulja Boy in the crypto space.

As being US based he is supposed to be following FTC guidelines yet has ignored them.

He was recently charged by the SEC for Tron & was sued for Safemoon.

Washington D.C., March 22, 2023 — The Securities and Exchange Commission today announced charges against crypto asset entrepreneur Justin Sun and three of his wholly-owned companies, Tron Foundation Limited, BitTorrent Foundation Ltd., and Rainberry Inc. (formerly BitTorrent), for the unregistered offer and sale of crypto asset securities Tronix (TRX) and BitTorrent (BTT). The SEC also charged Sun and his companies with fraudulently manipulating the secondary market for TRX through extensive wash trading, which involves the simultaneous or near-simultaneous purchase and sale of a security to make it appear actively traded without an actual change in beneficial ownership, and for orchestrating a scheme to pay celebrities to tout TRX and BTT without disclosing their compensation.

The SEC simultaneously charged the following eight celebrities for illegally touting TRX and/or BTT without disclosing that they were compensated for doing so and the amount of their compensation.

3/ EX 1: RapDoge

On July 19, 2021 Soulja Boy Tweeted out: "let's pump \$RAPDOGE to \$.000001 and let's get all our friends in on this are you with me lilyachty"

In the following hours the project rug pulled after receiving shills from Lil Yachty and Quavo as well.

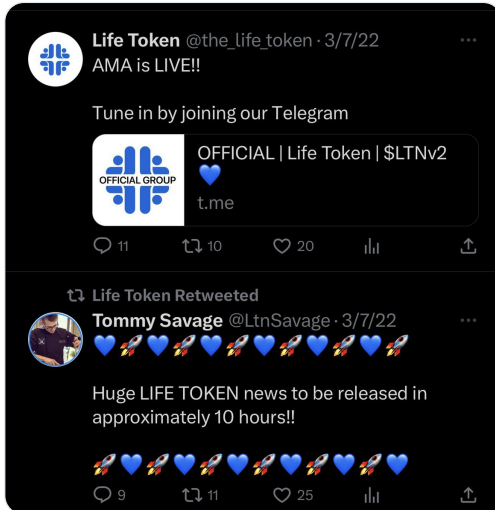

4/ EX 2 & 3: Orion & The Life Token

These two projects used cancer and suicide prevention charities as a means to pump the price.

Within one of month of the shell Orion rugged and Twitter was deleted.

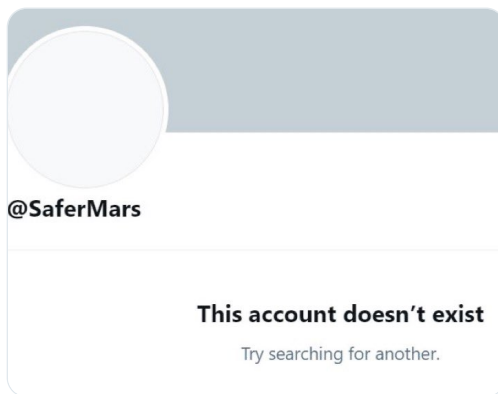
The Life Token was abandoned in early 2022.



5/ EX 4: SaferMars

As probably his most infamous skill, SouljaBoy accidentally left his compensation details in the promotion tweet and left it up before noticing.

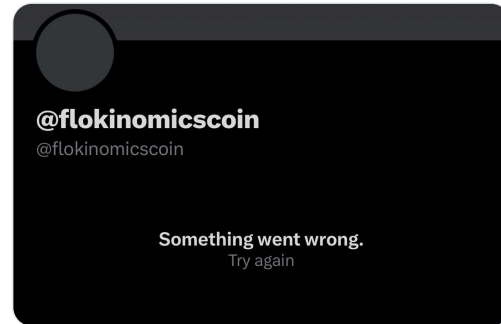
The project soon rug pulled after and he deleted his tweets to remove evidence.



6/ EX 5: Flokinomics

On Oct 9, 2021 Soulja Boy tweeted about a scam that blatantly paid for media features and claimed it was created by Elon Musk.

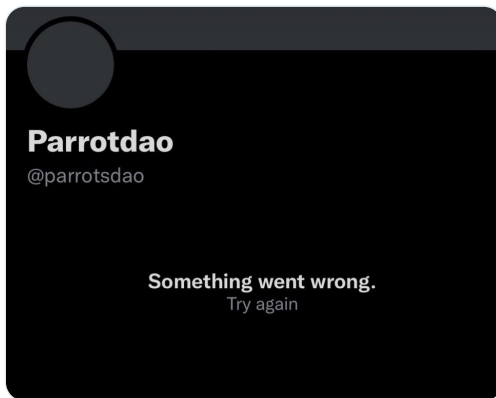
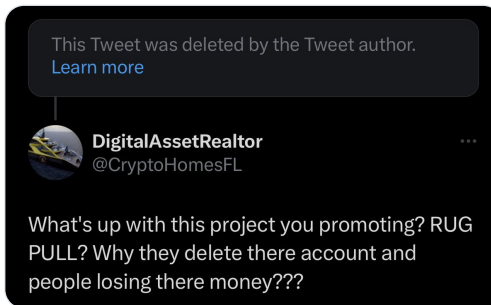
Eventually the twitter & website were deleted



7/ EX 6: ParrotsDAO

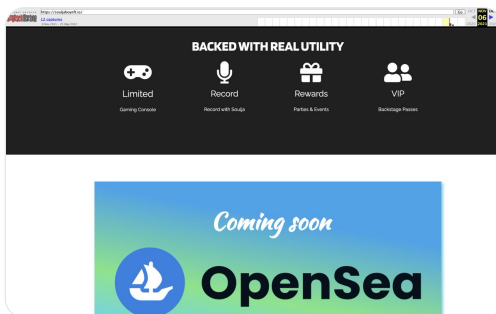
Soulja Boy tweeted “Get yo money up and stake!”

In next 24 hrs the project rug pulled and he deleted all evidence once again.



8/ Soulja Boy has dropped many different NFT collections. In 2021 alone I found 9 total collections created by him.

One of them called SouljaBoyNFT advertised many forms of utility yet the website is offline.

9/ Then just in April 2023 SouljaBoy has dropped 7 different NFTs.

The first included a 3D NFT which used the Ferrari & Nike logo. Within a few hours this was blocked from OpenSea for IP infringement.


It seems he has yet to reimburse the buyers for it.



10/ Some of the recent NFT drops by him have advertised utility such as exclusive unlocks for his upcoming blockchain video game and other member only benefits.

He has continued to create more NFTs disregarding buyers of previous collections.






