


Thankfully NJ/PB connected their wallet addresses from CBOT & BABYSHIB shills to PAAL making it easy to find

To be clear, I have not at any point been paid to promote anything that has been suggested in these tweets or the content contained within them.


I have made my feelings clear to NJ and Petabyte as to the fact they believed they could without my knowledge or consent leverage off my profile to generate deals that would financially benefit them.




3/ How did I confirm which one was Trader SZ wallet?


Well he received multiple honorary NFTs to this wallet






4/ Trader NJ claimed this wallet address on Telegram was Trader XO although it is not clear if he was lying if this address belonged to someone else in their group

5/ Both XO & SZ began aggressively shilling PAAL across Twitter with NJ and PetaByte.


I do not see any disclosures about receiving the free tokens?









6/ The PAAL Twitter account reached out to me recently to confirm that XO, SZ, NJ, PetaByte were all dumping their tokens after shilling.








7/ Trader SZ received 4M PAAL from their team on Aug 10 and began shilling a few days after. Shortly after that was when he began dumping.

In total I found had SZ dumped \$130k+ worth of PAAL (all of his tokens)




8/Here Trader NJ says his "PAAL conviction has not changed"


